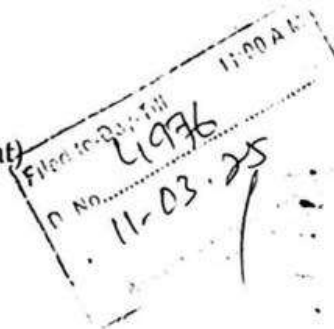

Through this writ petition, the petitioner seeks quashment of the impugned notices dated 28.10.2024, 17.02.2025, and 13.02.2025 issued by the HEC/Respondent No.1. The petitioner further seeks directions for Respondent No. 1 to attest and verify all degrees awarded by IRŞA University.

2. Learned counsel for the petitioner contends that Isra University is functioning in accordance with the law and as per its own charter. However, HEC has issued the subject letters in violation of Section 10 of the HEC Ordinance 2002, wherein they have stopped and blocked the functioning of the university. Learned counsel further argued that HEC has no jurisdiction to pass such orders against a chartered university under Section 10 of the HEC Ordinance 2002.

3. Question raised needs consideration. Let notice be issued to the respondents for 22.04.2025.
